Scheduled Election

Fair Work (Registered Organisations) Act 2009

Nominations are called for:

- Branch Secretary (National Executive Member, National Conference Delegate) (1)
- Branch President (honorary) (1)
- Branch Assistant Secretaries (2)
- Branch Senior Vice Presidents (2)
- Branch Vice Presidents (3)
- Branch Executive Committee Members (honorary) (15)
- National Executive Members (honorary) (2)
- National Conference Delegates (honorary) (9)

Nominations, which must be in writing and comply with the registered rules of the Organisation, may be made at any time from 13/01/2021.

A nomination form is available on the AEC website at www.aec.gov.au/ieb. However, the nomination form must then be lodged in accordance with the Organisation's rules (see below). Additional forms are available from the Returning Officer.

Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below **not later than** 12:00pm Australian Eastern Daylight Time (AEDT) **on** 27/01/2021.

How to lodge nominations, nominations must be lodged via the following method:

By Email: A properly completed nomination form including all necessary signatures and attachments may be scanned and submitted as a pdf file to **IEBnominations@aec.gov.au**

PLEASE NOTE:

1. Emails to the AEC inbox that appear to be spam may be blocked. It is the responsibility of senders to ensure that their email reaches the AEC before the deadline for nominations.
2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.
3. You may call 02 9375 6375 to enquire about the status of your nomination.

After the close of nominations, where a candidate has nominated for more offices than the rules allow, the Returning Officer will only consider the nomination received last in time. Where the Returning Officer is unable to determine which nomination was received last in time, all nominations will be defective.

Withdrawing Nominations

Nominations cannot be withdrawn after 12:00pm (AEDT) on 03/02/2021.

Voting Period

The ballot, if required, will open on 21/04/2021 and close at 12:00pm (AEST) on 17/05/2021.

Scrutineers

A form is available from the Returning Officer for the purposes of appointing Scrutineers.
